

## A Lot Has Changed!



#### Current Situation

- San Lorenzo Unified has changed to a Distance Learning platform, due to the Shelter in Place orders from the Governor and County Public Health Departments.
- Many current state and local programs have been cancelled or put on hold due to the difficulties the school closures have caused
- State funding to schools is also predicted to be adversely affected by the closures—schools depend on state tax revenues; individuals and companies may not pay as much as normal, due to a greatly reduced economy and job loss.
- All state assessments have been cancelled, which includes the suspension of the Data Dashboard process and Differentiated Assistance programs

## A Lot has Changed!



- LCAP is also Changing
  - As of Friday, April 24<sup>th</sup>, the state legislature took legal action to separate school district funding from the LCAP plan
  - District funding won't be released until August, and may include drastic cuts to Supplemental/Concentration Grant funds and other funds
  - The LCAP plan itself has been put on hold, and will not be due until December 15<sup>th</sup> (due prior to the ACOE and Board of Education for approvals).
  - A new LCAP template will also be developed for the new due date

## A Lot has Changed!

- New: District Operations Plan
  - A plan for how the school district will operate to support our English learners, low income students and foster youth (unduplicated students) from August-December will be due to the CDE by June 30<sup>th</sup> (Board meeting June 16<sup>th</sup>)
  - The template for this plan was released on May 1<sup>st</sup>.



## Role of the LCAP Steering Committee

- Review the Operational Plan proposal for how the district will support students in the fall
- Provide input and feedback on the proposal
- Continue to provide input and feedback on the LCAP Plan development as we move into the 2020-21 school year
  - Learn more about how any budget changes may affect our district
  - Support the development of the new LCAP



## Where we left off.....



- March 2020
  - District had completed budget cut process
  - Differentiated Assistance goals had been developed in collaboration with the ACOE
  - New schools identified as participating in Comprehensive School Improvement—Colonial Acres exited the program, and Edendale and Royal Sunset have entered the program
  - LCAP Steering Committee was set to meet to review how each of these processes had changed the current LCAP actions and begin the discussions for plan development for the 20-21 school year

## How Do We Proceed?

- Discuss Distance Learning and options for the fall, should we need to continue to shelter in place or social distance ourselves
- Discuss current LCAP action plans, and modify language in the plan to support both regular school operations and distance learning operations
